## Welcome from the EAERE President

Dear EAERE friends and colleagues,

Welcome to the 27th Annual Conference of the European Association of Environmental and Resource Economists! After two years of very successful virtual conferences thanks to the talent and devotion of the amazing Berlin team lead by Georg Meran and Klaus Eisenack, it is with great pleasure that I welcome every one of you to this year's, in person, Annual Conference.

Over 1,200 papers were submitted and 532 have been selected for inclusion in the final programme. I am delighted to see that the enthusiasm for our conference series remains high: this Annual Conference counts over 700 participants, which is a great result considering the uncertainties linked to the pandemic and the current geopolitical situation.

For this I would like to deeply thank our colleagues and friends at the University of Bologna who - despite the need to move the conference by a year (the original plan was to gather in Rimini in 2021) and the uncertainties that have arisen over the last two years - accepted the challenge of organising our 27th Annual Conference. Sincere thanks to the University of Bologna and the entire Local Organising Committee chaired by Alessandro Tavoni. It was a huge effort, and we are very grateful for all the time and work they generously offered to our community. Our warmest gratitude goes also to Programme Committee co-chairs Marita Laukkanen, Alessandro Tavoni and Anastasios Xepapadeas, who together with the Local Scientific Committee - Elettra Agliardi, Emanuele Campiglio, and Niko Jaakkola - and with the important contribution of 380 referees, have prepared a rich scientific and social programme. The preparation of the programme was supported by the software produced by Anymeets who also deserves our gratitude. Our gratitude goes also to our Association's Secretariat team for its constant and careful work for the execution of the Conference. Monica, Silvia, Ottavia, Martina, you are our institutional memory and support the council and all other EAERE committees and initiatives, with enthusiasm, efficiency and consistency. Thank you! No EAERE president or council can survive without your excellent support.

Please see our <u>full conference programme</u>, which consists of plenary sessions, parallel paper sessions, egg-timers, three high-level policy sessions, a welcome reception, an informal social event and a conference dinner. A rich programme of related events is also available. The programme also includes two important association events: the session at which we will announce this year's awards and recognitions, and the General Assembly of Members. We are counting on everyone's participation to applaud and congratulate our outstanding colleagues and to define our future priorities and strategies together.

Our Annual Conference is perhaps the most important and awaited moment of the year for our community. However, I would like to emphasise that EAERE is not just an annual conference or a set of academic awards. Our Association is a much broader platform, capable of offering many other moments of exchange and enrichment for its members. EAERE is a science community and academy ecosystem that we want to empower and develop further.

Our portfolio of activities is already very rich and includes two very well reputed flagship journals: Environmental and Resource Economics - ERE, and the Review of Environmental Economics and Policy - REEP. I would like to take this opportunity to express our warmest gratitude to the journals editors Ian Bateman (ERE) and Cathy Kling (REEP) as well as the co-editors for their time and commitment to the journals. As recently announced, Cathy is stepping down from her position as REEP editor at the end of 2022, her fifth year in a highly successful tenure. We want to thank Cathy for her many years of service to the journal and to the profession and want to welcome Spencer Banzhaf as next editor of REEP, wishing him much success...

Our portfolio includes also successful educational activities: our Summer School run by Michael Finus and Karl Steininger with the University of Graz, or our Winter School run by Lucas Bretwschger with ETH Zurich, a series of policy webinars jointly organised with CEPR and led by Carlo Carraro, Ottmar Edenhofer and Christian Gollier, an informative quarterly Magazine edited by Frank Convery, a monthly newsletter, and many activities coordinated by our Policy Outreach Committee led by Jos Delbeke and Simone Borghesi (observer status at the UNFCCC, IPCC, the European Chemical Agency are only some examples).

We are working to improve the capacity of our Association to offer its members an even broader and modern platform, which will seize inspiring and new stimuli for their research. As per my nomination letter and keeping the political and ethical challenges in mind, my vision for EAERE is to mobilise and involve our community in new activities that will increase its impact on science (disciplinary and interdisciplinary science) technology and business development, and policy. We will discuss in detail all these activities at our General Assembly. Below I present a selected number of the ones we are working on.

- Financial sustainability and global outreach of the association through the launch of new initiatives that can support the association's finances while providing opportunities for increased membership and collaboration among our institutional members. With this in mind, we will soon announce a model for a series of Science-Policy-Business Interface webinars that will be organised in cooperation with our members.
- Impact on policy through our Policy Outreach Committee task forces linked to respective European Commission DGs and sections of Multilateral organizations that shape global policy-making (UN, IPCC, EIB, ECB, etc.). Task forces are important in terms of having the capacity to produce annual or bi-annual reports (in collaboration with EAERE member institutions) that can facilitate the interaction with policy makers.
- Support diversity, equity and inclusion initiatives. This initiative will be launched in September and at first it will follow a virtual living lab format lead by Ebun Akinsette. We have recently launched a call for expressions of interest for an Executive Committee that will lead these initiatives. We are very proud to include them in our agenda.

- A closer collaboration with the other Associations of Environmental and Resource Economists (American, Latin American, African, Asia, Australian), towards global events and initiatives under the umbrella of the World Council of Environmental and Resource Economists Associations (WCEREA). After a break following the decision to skip a World Congress cycle, the World Council resumes its activities in July with some important items on its agenda, like the definition of the process for assessing applications for WCEREA membership from other associations, WCEREA mission and activities, future events. The WCEREA is a potentially formidable booster to exploit synergies amongst associations worldwide, and we do not want to miss this opportunity. We are already in close communication with the Latin American, North American, Asian, African and Australian associations active in our field.

- Launch of a book series on cutting-edge research topics that we hope will provide useful insights for future research. The book series was inspired by my conversations with many of our senior and junior members, that told me that they usually find that review articles are never long enough to provide the research community with deep technical knowledge and holistic review of a topic. We will prioritize the EAERE Fellows, the most prominent people of our association, as the first round of potential authors for this small books series.

- Transition to hybrid annual conferences and other events to increase the cohesion of the network of our members, as well as the outreach of our activities across the world and to members with physical, social or financial constraints. This transition has been imposing many challenges and difficulties mainly due to the uncertainty related to the kind of participation preferred by our members and the limited financial resources available for each annual conference.

Our Council (and I want to thank Simone Borghesi, Enrica De Cian, Simon Dietz, Christian Gollier, Asa Lofgren, Marita Laukkanen) has started to work along these lines, relying on the support and contribution of our members through open calls and discussions for maximum inclusiveness, transparency, and cohesion. Some of you may have noticed that in the menu bar of our website we have made the 'contact us' button very prominent, through which you can contact me, our Council and the Secretariat, with your proposals, comments, new ideas, criticisms. We will be happy to listen to all our members and no message will go unanswered.

Enjoy the intellectual stimulation and social interaction of our conference, in the lively city of Rimini. I look forward to meeting you in our General Assembly of Members taking place on June 30th, from 13 to 14 CEST. Those members who are not attending the Rimini conference in person can participate online.

Enjoy and please communicate your thoughts, ideas and vision, to us! We need you in order to do our job well!



Pre-conference Workshop of the 27th Annual EAERE Conference

#### The economics of a just and equitable transition

27-28 Jun 2022, Hybrid Workshop: Onsite and online

Organizing committee: Jan Steckel (MCC) Massimo Tavoni (RFF-CMCC) Elena Verdolini (RFF-CMCC)

The aim of this workshop is to discuss how methods in environmental and resource economics can contribute to assess and quantify the impact of the low carbon transition on certain parts of society, and how they can be alleviated. It will present approaches to identify policies that can be put in place to correct pre-existing and transition-induced inequalities. The workshop will thus focus on issues related to employment, distributional impacts of policies, and public acceptance of the climate transition, with the aim to foster a debate on the research and policy agenda focusing on the Just Transition.

Addressing climate change will only be successful when related policies are perceived as fair and equitable. Climate change impacts will lead to severe economic losses, unevenly distributed across countries and regions, generations and individuals; they will aggravate existing inequalities and create new ones. Yet, the costs associated with the energy transition or external shocks may also disproportionately burden vulnerable households, firms, communities and social groups. The EAERE community has long addressed topics linked with the distributional impacts of climate change policies, and their repercussions on and prospect for the labor market and the public perception around tradeoffs between mitigation and economic growth. In recent years, novel methods have emerged to approach these topics. A deeper and meaningful dialogue can be fostered by building bridges between different research communities within and outside of EAERE.

#### Program:

The workshop has two aims. First, it takes stock of the methods in economics and other social sciences which can contribute to an assessment of the Just Transition. It will explore how methodologies and assessment tools used in climate economics and modeling have been used to inform the debate regarding a just transition. Recent developments, theoretical, empirical and numerical, will be discussed to highlight how different methodological approaches can contribute to the academic debate on key topics relevant for the Just Transition. Second, it looks forward and discusses how to develop the Just Transition research agenda with the aim of informing the policy debate. This includes broadening the attention to methods and insights from other research fields, as well as discussing how to use the available evidence to inform the current policy debate and identify key knowledge gaps and potential avenues for future research.

#### Format:

The workshop is organized in three thematic sessions: Workforce and Employment, Vulnerable Households and Firms, and Public Acceptance. Each session will last approximately for one and half hours and will present short talks by invited speakers, followed by discussion among participants. A final round table discussion will gather reaction from high-profile individuals engaged in research and policy making.

Onsite participation is free and open to the public and will take place in Aula Alberti 10 of the UniBo Rimini Campus (Piazzetta Teatini, 13, Rimini RN). Onsite registration is open until June 10 or until room capacity is reached.

#### Keynote - David Pearce Lecture

#### Economic possibilities in the Anthropocene

Prof. Sir Partha Dasgupta, University of Cambridge



Partha Dasgupta is Frank Ramsey Emeritus Professor of Economics at the University of Cambridge, Fellow of St John's College, Cambridge, and Professorial Research Fellow at the Sustainable Consumption Institute, University of Manchester. He taught at the London School of Economics during 1971-1984 and moved to the University of Cambridge in 1985 as Professor of Economics, where he served as Chairman of the Faculty of Economics in 1997-2001. During 1989-92 he was also Professor of Economics, Professor of Philosophy, and Director of the Program in Ethics in Society at Stanford Univer-

sity; and during 1991-97 he was Chairman of the (Scientific Advisory) Board of the Beijer International Institute of Ecological Economics, Stockholm. Since 1999 he has been a Founder Member of the Management and Advisory Committee of the South Asian Network for Development and Environmental Economics (SANDEE), Kathmandu. In 1996 he helped to establish the journal Environment and Development Economics, published by Cambridge University Press, whose purpose has been not only to publish original research at the interface of poverty and the environmental-resource base, but also to provide an opportunity to scholars in developing countries to publish their findings in an international journal.

Professor Dasgupta's research interests have covered welfare and development economics, the economics of technological change, population, environmental and resource economics, the theory of games, the economics of undernutrition, and the economics of social capital.

#### Plenary address

Mr. Daniele Franco, Minister of Economy and Finance



Daniele Franco is the Italian Minister of Economy and Finance. Before his appointment in February 2021, he was Deputy Governor of the Bank of Italy (May to December 2019), then Senior Deputy Governor (January 2020 to February 2021). Within Bank of Italy, he also worked in the Economic Research Department of Bank of Italy (1979-1994), as head of the Public Finance Division of the Economic Research Department of Bank of Italy (1997-2007), as head of Structural Economic Analysis Department (2007-2011) and as Managing Director of the Economic Research and International Relations (2011-

2013). He also woried as an Economic Advisor at the European Commission's Directorate General for Economic and Financial Affairs (1994-1997) and he held the position of State Accountant General at Italy's Ministry of Economy and Finance (2013-2019). Over the course of his career, he has widely published and held lectures on public finance, social protection and income distribution, and has participated in committees and working groups at various national and international organizations.

#### Keynote

#### How Should Climate Change Uncertainty Impact Social Valuation and Policy?

Prof. Lars Peter Hansen, Becker Friedman Institute for Economics at the University of Chicago



Lars Peter Hansen is a leading expert in economic dynamics who works at the forefront of economic thinking and modeling, drawing approaches from macroeconomics, finance, and statistics. He is a recipient of the 2013 Sveriges Riksbank Prize in Economic Sciences in Memory of Alfred Nobel. Hansen has made fundamental advances in our understanding of how economic agents cope with changing and risky environments. He has contributed to the development of statistical methods designed to explore the interconnections between macroeconomic indicators and assets in financial

markets. These methods are widely used in empirical research in financial economics today.

#### Keynote

#### The Social Cost of Nutrient Pollution

Prof. Catherine L. Kling, Dyson School of Applied Economics and Management, Atkinson Center for a Sustainable Future at Cornell University



Catherine L. Kling is a Tisch University Professor in the Dyson School of Applied Economics and Management and Faculty Director at the Atkinson Center for a Sustainable Future. She is past Director of the Center for Agricultural and Rural Development at Iowa State University where she also held the President's Chair in Environmental Economics. She was elected to the National Academy of Sciences in 2015. Kling has published nearly 100 refereed journal articles and books chapters which have received over 8000 (google scholar) citations and is the editor of the Review of Environmental

Economics and Policy. She specializes in the economic valuation of ecosystem services and integrated assessment modeling for water quality modeling. Her research program has received over \$7 million in funding from the National Science Foundation, the US Department of Agriculture, the Iowa Department of Natural Resources, the US Environmental Protection Agency, among others. Kling chairs the Water Science and Technology Board of the National Academy of Sciences and has been a member of six National Research Council studies. She served as president of the Association of Environmental and Resource Economists, has held editorial positions at ten economics journals, and has received seven awards from professional associations for her research. She is an elected Fellow of the Association of Environmental and Resources Economists, the Agricultural & Applied Economics Association, and a University Fellow at Resources for the Future. She served for ten years on EPA's Science Advisory Board.
